CHIEF JUSTICE CLARKSON ANNOUNCES CONCLUSION OF TERM IN DECEMBER

Rockford Hills, Los Santos (City Hall): The Honorable Chief Justice of the San Andreas Judiciary today announced that his term as Chief Justice will come to an end in December of 2024. After approximately one year of dedicated service to the Courts and the citizens of San Andreas as the Chief Justice, Chief Justice Kylian J. Clarkson reflected on the progress made, the challenges overcome, and the collective strength of the legal community that has supported him throughout his tenure.

"It has been absolutely nothing but an honor to serve as your Chief Justice," said Chief Justice Clarkson. "The Judiciary was in shambles, Judges were straining, Citizens were disgruntled and we managed to repair and resolve most of the issues during my tenure as Chief Justice." Chief Justice Clarkson further stated. "None of what has been accomplished would have been possible without the hardwork and dedication of our Judges, Magistrates, Clerks, and Lawyers. Their commitment has been nothing short of amazing. I also want to extend my deepest thanks to the people of San Andreas for their trust and unwavering support. Together, we've made real progress in strengthening our judicial system, and for that, I'm incredibly grateful."

Over the past year, the Chief Justice, alongside his colleagues, has overseen numerous judicial reforms, modernized court procedures, and enhanced access to justice. A few highlights of his accomplishments include:

Key Accomplishments During Term:

Time Limits for Trials:

- Judicial Efficiency and Trial Time Limits: The introduction of streamlined court procedures to ensure that trials run efficiently and fairly, reducing delays and improving outcomes.
- **Increased Staffing Levels:** The judiciary expanded to include 10 judges and 10 clerks, the largest staffing level in the state's history, ensuring efficient case handling and accessibility.
- Expanded Clerk Responsibilities: Court Clerks' roles were significantly expanded to handle critical functions such as background checks, depositions, bar and notary card issuance, and marriage certificates.
- **Power of Attorney System (POA):** Temporarily introduced the POA system, which provided important legal frameworks before its invalidation. It is now awaiting resubmission by the legislature for further improvements.
- Speedy Trial Act (STA): Implemented the STA reform, resulting in a 90% reduction of cases dismissed due to STA violations, ensuring timely justice and minimizing procedural delays.
- **Judiciary Portal:** Introduced a comprehensive portal for the public, lawyers, and judges, modernizing case management and providing transparency in the judicial process.
- Court Procedure and Notary Overhaul: Led a complete overhaul of court procedures and transformed the Standard Operating Procedures (SOPs) for notaries, streamlining operations and increasing efficiency.
- Warrant Guidelines: Created detailed warrant guidelines to assist law enforcement in the preparation and submission of warrants.
- A Sidebar and Tobacco: Co-purchased a business with fellow judges and lawyers, creating a social and professional community space for legal professionals to connect outside of court.
- **Transparency and Communication:** Increased transparency to the general public and repaired interdepartmental relationships.

"I leave this position confident in the strength of the Judiciary and the future of Justice in San Andreas. While I will no longer serve as Chief Justice, I remain committed to supporting the legal community and will continue to contribute to the legal profession in any capacity I can," Chief Justice Clarkson added.

As December approaches, the Chief Justice encourages continued collaboration and dedication from all branches of the legal system. He remains deeply grateful for the opportunity to have served and looks forward to the future leadership that will guide the judiciary forward.
